PDT MACRON DECIDED NOT TO LOCKDWON SO FAR AND TRUSTED THE FRENCH PEOPLE

BORDERS CLOSED TO NON EU COUNTRIES

USPA NEWS - The French have been waiting for the announcements of new health measures vis-à -vis the pandemic to set against the spread of COVID-19, for a week supported by suspense, because media rumors, suppose a near confinement "greenhouse", or a curfew, earlier, than the current one of 6 p.m., unless it is, the closing of schools ...A new Defense Council took place at the Élysée on Friday, January 29, 2021 at 6 p.m., with the announcement of the next health measures to avoid confinement as much as possible. At the end of this restricted Council of Defense and National Security, the Prime Minister, Jean Castex took the floor, from Elysee Palace, to announce the new measures put in place in France in the fight against the coronavirus. We discover its announcements together. There will therefore be no containment for listing. The President of the Republic, Emmanuel Macron, said he wanted to "trust the French" and prefers "to give himself a little time" to see if a third confirm will be decided or not. The restaurants and their culture (cinemas, theaters, operas, performance halls ...) and sports halls remain closed. Small businesses, meanwhile, remain open until the curfew at 6 p.m.

COVID-19 and PCR tests of at least 72 hours are mandatory for all travelers coming from all countries (including European Union countries) with the exception of road carriers and cross-border workers. Travel from or to France and countries outside the EU are now prohibited, from Sunday January 31. The borders between France and countries outside the European Union are therefore closed, "unless there are compelling reasons". A new defense council will have it next week, before announcing new measures, at the dawn of the next school holidays, which begin on February 8, 2021.

NEW MEASURES FROM MARCH 31, 21 IN FRANCE TO COMBAT COVID-19------

A new Health Defense Council was held this Friday, January 29, 2021 at the Élysée. Jean Castex took the floor at the end of this council to announce the new decisions that have been taken by the government, which continues to closely follow the evolution of the pandemic in France.

NON ESSENTIAL STORS (MALLS> 2000 m2) MUST CLOSE FROM JANUARY 31-------

At the end of the Defense Council meeting urgently, French Prime Minister Jean Castex announced a new series of restrictions. Among them, the closure of non-food shopping centers of more than 20,000 m², from Sunday January 31.

FRANCE IS CLOSING ITS BORDERS TO NON-EU COUNTRIES EXCEPT FOR « IMPERIOUS REASONS »-------

The French PM, Jean Castex once again spoke this Friday, January 29, 2021 in order to take stock of the health situation. The Prime Minister notably announced more border restrictions. Thus, as of Sunday January 31, the borders with countries outside the European Union will be closed, "unless there are compelling reasons".

THE 6H pm CURFEW REMAINS & MORE THAN 30% OF THE POLICE CONTROLS IMPLEMENTED BY MINISTER OF INTERIOR G. DARMANIN------

While the French expected an imminent new lockdown, Prime Minister Jean Castex announced, on January 29, new restrictions including reinforced controls on non-observance of the curfew, clandestine parties as well as illegal openings. This Saturday, there was an "increase of more than 30% of controls" according to Gerald Darmanin.

TELEWORKING MAINTAINED AND REINFORCED BY THE STATE AID SYSTEM WITHIN COMPANIES------

The French Prime Minister Jean Castex announced, during a speech this Friday, of January 29, new restrictive measures and called

on companies to strengthen teleworking for their employees. A decision that goes against what, the French Minister of Labor, Elisabeth Borne who announced last December, considering an easing of the rules for teleworking, allowing employees to go to companies at least once a week.
